The Finance Committee proposes to reduce M&M's for each congregation by the amount of their invoiced Presbytery Dues (£2.70 per member) plus their Survey Dues (£0.80). This means that each congregation will not be charged by Presbytery for each member they have, thus ideally seeking to promote mission and membership of the Kirk

.

Further, there remains a balance of £5,756 in the reserve. The Finance Committee therefore proposes to reduce M&M's proportionately to the three-year average income base of each congregation used by 121 to calculate the annual amount of M&M contributions at the start of 2016.

The total M&M reduction for each congregation is shown in the following table. Treasurers should continue to pay the monthly regular amount of M&M's and deduct the amount in the table from the final instalment due to 121. This is usually done by cancelling the standing order in favour of 121 prior to the payment of the final instalment, and by making a manual payment of the balance by cheque.
